In addition, PVK has been Chief Counsellor in the Danish Ministry of Foreign Affairs, Department of International Law and Human Rights; Head of the International Law Department at the Danish Red Cross; Legal adviser in DIGNITY working with international projects on prevention of torture; worked as a judge in a Danish district court, and with international asylum- and refugee law in the Danish Ministry of Interior, for the UNHCR and as a member of the Danish Refugee Appeals Court (six years).
