INTERAGENCY ACTION PLAN for 2016-2019

On implementing the accepted recommendations from the Second Universal Periodic Review of the UN Council and from the Human Rights Treaty Bodies

The Interagency Action Plan for 2016-2019 on implementing the accepted recommendations from the Second Universal Periodic Review and from the Human Rights Treaty Bodies (hereinafter, the Interagency Plan) is a programmatic document designed to facilitate the compliance of the Republic of Belarus with its international obligations in the area of human rights, including improving the legal framework and enforcement practices.

In Belarus, the key human rights and liberties are enshrined in the Constitution; they have been recognized as an integral part of the core values and a key objective of the state and society. The primacy of the fundamental principles of international law has been recognized at the constitutional level.

Belarus is a sovereign, dynamic state that has made many important achievements in the area of human rights.

According to the United Nations Development Programme (UNDP) data, Belarus has advanced to the top 50th position in the human development index, thereby ranking among the countries with a high level of human development.

According to the United Nations Population Fund (UNFPA) data, in 2014 Belarus ranked 1st worldwide in reducing maternal mortality, and was listed among 42 countries in which 100% of births are attended by skilled medical personnel.

According to the United National International Children's Emergency Fund (UNICEF) report, Belarus had the lowest child mortality rate in the Commonwealth of Independent States (CIS) region as of December 2014. Belarus has become one of 25 countries with the most favorable conditions for maternity, and ranks 31st globally by the gender equality index.

In 2016, the World Health Organization (WHO) acknowledged Belarus' success in achieving full prevention of HIV and syphilis mother-to-child transmission.

Belarus' performance and achievements in other areas have also been recognized by the international organizations.

Belarusian national legislation on human rights is based on the principal international human rights documents.

The Republic of Belarus is a party to the majority of international human rights treaties. Belarus cooperates with the human rights treaty bodies and submits its periodic reports on the fulfilment of its international obligations to them. The final recommendations of the treaty bodies are taken into consideration during the review and amendment of the national legislation and policies on the protection and promotion of human rights.

In its approaches and strategies on human rights protection and promotion, Belarus has consistently viewed civil and political, social and cultural rights as indivisible, interrelated, interdependent and complementary.

The Republic of Belarus maintains constructive collaboration with the international human rights mechanisms, as well as a dialogue with the special procedures of the United Nations Human Rights Council (UNHRC); it also cooperates with the Office of the UN High Commissioner for Human Rights and a variety of programs, funds and specialized agencies of the United Nations (UN).

Belarus considers the UN Council Universal Periodic Review as the most important mechanism to support the development of a constructive international partnership in the field of human rights, and a means of enhancing a mutually respectful dialogue.

The Interagency Action Plan serves to further strengthen national capacity in implementing the international obligations of the Republic of Belarus in the field of human rights.

The Interagency Action Plan is a long-term document aimed at the achievement of the following objectives:

building national capacity to effectively meet the international obligations of the Republic of Belarus in line with international human rights treaties;

identifying human rights challenges and developing appropriate legislative and institutional responses;

effectively applying international best practices to improve national human rights policies;

building capacity of the state institutions in the area of human rights;

improving the state system of human rights oversight, ensuring better transparency of the outcomes;

expanding public and private partnership in the area of human rights;

supporting the most vulnerable groups;

improving data collection and analysis on all aspects of human rights and liberties using the indicators that signify the fulfilment of the international standards and requirements on human rights and liberties in accordance with the international requirements.

The implementation of the Interagency Action Plan will facilitate the implementation of the activities prescribed by the government programs intended to safeguard the rights of Belarusian citizens; it will also support the implementation of the current 2016-2020 UN-Belarus Development Assistance Framework (UNDAF), and the country programs of UNDP, UNICEF and UNFPA for 2016-2020.

The Interagency Action Plan will also contribute to the achievement of the goals and objectives of the Republic of Belarus in line with the International Sustainable Development Agenda until 2030.

The activities of the Interagency Action Plan for 2016-2019 on implementing the recommendations from the Second UN Universal Periodic Review accepted by Belarus, as well as the recommendations received from the Human Rights Treaty Bodies for 2016-2019 will be executed in accordance with the annex by the bodies of the national and local governments and administrative authorities in collaboration with academic and religious organizations, as well as public associations with the assistance of the financial and technical expertise of international organizations.

The activities of the Interagency Action Plan will be financed within the limits of the national and local government budgets, the extrabudgetary Social Security Fund of the Republic of Belarus, as well as from other legitimate sources, in order to achieve the respective objectives.
